AN ORDINANCE GRANTING LESTER R. HARNETIAUX TRUST A

WHEREAS, an application has been filed by Linda J. LeBegue as Trustee of the Lester R. Harnetiaux Trust requesting Conditional Use permit for a multi-family dwelling at 308 S Third Street in a commercial neighborhood zone in Greenville, Illinois, and,

WHEREAS, the question of granting said conditional use permit was referred to the Planning Commission of the City of Greenville to hold a public hearing thereon, and,

WHEREAS, said public hearing was duly held, after proper public notice in the manner provided by law, and,

WHEREAS, said Commission made a report containing findings of fact and recommending the granting of said amendment.
