WHEREAS, a request has been made to amend the Use Matrix Table 153.0202(A) of the Unified Development Code in the City Code to allow single-family attached and detached dwellings as a conditional use in the Commercial General zone, and

WHEREAS, a request has been made to amend the Use Matrix Table 153.0202(A) of the Unified Development Code in the City Code to allow car washes as a permitted use in the Commercial Neighborhood zone, and

WHEREAS, both requests were referred to the Planning Commission of the City of Greenville to hold a public hearing thereon, and

WHEREAS, said public hearing was duly held, after proper public notice in the manner provided by law, and

WHEREAS, said Commission made a report containing findings of fact and recommendation to allow single-family attached and detached dwellings as a conditional use in the Commercial General zone, and

WHEREAS, said Commission made a report containing findings of fact and

recommendation to allow car washes as a permitted use in the Commercial Neighborhood zone, and

WHEREAS, The City Council of the City of Greenville, Bond County, Illinois, in meeting assembled, does hereby adopt an ordinance to amend the Use Matrix Table 153.0202(A) to alter the conditional use of category single-family attached and detached dwellings in the Commercial General zone, and to alter the permitted use of car washes in the Commercial Neighborhood zone; and,

NOW THEREFORE, let it be ordained by the Mayor and the City Council of the City of Greenville as follows:

SECTION 1 – GENERAL STATEMENT: The City of Greenville's City Council hereby amends the Unified Development Code Use Matrix Table 153.0202(A) for Residential Buildings and Commercial Buildings to:
