WHEREAS, it is desired that the Greenville Code of Ordinances Chapter 94.10: Health and Sanitation; be amended in the following respects:

That portion of Section 94.10, being:

94.10 WEEDS.

(A) It shall be unlawful for any owner, lessee or occupant, or any agent, servant, representative or employee of any such owner, lessee or occupant of any lot of ground or premises, or any part thereof, to allow or maintain upon such lot or premises, or upon the street or right of way adjoining such premises, or to allow any adjoining sidewalk to be encumbered by any growth or weeds to be height of over ten inches, or any weeds which give off any noxious or unpleasant odors.

(B) Whenever any owner of real estate refuses or neglects to cut weeds, as defined above, within ten days after having been given notice to cut such weeds by certified mail by the Code Enforcement Officer, their designee, and or City Manager, the weeds shall be cut by the city; and a lien filed pursuant to 65 ILCS 5/11-20-7.

94.10 WEEDS.

SECTION 2-REPEAL: All prior Ordinances and/or Resolutions, which are inconsistent with the provisions of this Ordinance are hereby repealed.

SECTION 3-SAVINGS PROVISIONS: In the event any section, subsection, sentence or phrase of this Ordinance should be declared invalid, all other provisions hereof shall not be affected by such invalidity and shall remain in full force and effect.

SECTION 4-EFFECTIVE DATE: That this Ordinance shall remain in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
