ORDINANCE VACATING AN ALLEY

WHEREAS a request was received from The Simple Room to vacate an alley between Franklin Avenue and Willard Street, Greenville, Illinois, which is described as follows;

Alley running from North to South between Franklin Avenue and Willard Street, and adjoining Lot 4 of Railroad Addition and W 58' of Lot 1 of Railroad Addition and W 51' of Lots 2 & 3 of Railroad Addition.

WHEREAS, the request is made to allow for potential construction of a new facility;

WHEREAS, the City Council reviewed the request and recommends vacating alley running from North to South between Franklin Avenue and Willard Street, and adjoining Lot 4 of Railroad Addition and W 58' of Lot 1 of Railroad Addition and W 51' of Lots 2 & 3 of Railroad Addition;

BE IT ORDAINED by the City Council of the City of Greenville, of Bond County, Illinois, that alley running from North to South between Franklin Avenue and Willard Street, and adjoining Lot 4 of Railroad Addition and W 58' of Lot 1 of Railroad Addition and W 51' of Lots 2 & 3 of Railroad Addition shall be vacated.

This ordinance shall be effective from and after its passage and approval as required by law.
