ORDINANCE VACATING AN ALLEY

WHEREAS a request was received from Mark and Judy Brooke to vacate an alley between Hena Street and Dewey Street, Greenville, Illinois, which is described as follows;

Alley running from West to East from Hena Street to Dewey Street between Main Street and South Avenue extension.

WHEREAS a request was received from City of Greenville to vacate an alley between Hena Street and Dewey Street, Greenville, Illinois, which is described as follows;

Alley running from West to East from Hena Street to Dewey Street between the South Avenue extension and Vine Street.

WHEREAS, the request is made of an unimproved alley surrounded by privately owned residential parcels with no plans of future use;

WHEREAS, the City Council reviewed the request and recommends vacating alley running from West to East from Hena Street to Dewey Street between Main Street and South Avenue extension and alley running from West to East from Hena Street to Dewey Street between the South Avenue extension and Vine Street;

BE IT ORDAINED by the City Council of the City of Greenville, of Bond County, Illinois, that alley running from West to East from Hena Street to Dewey Street between Main Street and South Avenue extension and alley running from West to East from Hena Street to Dewey Street between the South Avenue extension and Vine Street.


This ordinance shall be effective from and after its passage and approval as required by law.
