ORDINANCE NO. 3138

AN ORDINANCE MAKING APPROPRIATIONS FOR THE SEVERAL DEPARTMENTS AND FUNDS OF THE CITY OF GREENVILLE, ILLINOIS FOR THE FISCAL YEAR COMMENCING MAY 1, 2017 AND ENDING APRIL 30, 2018

BE IT ORDAINED by the City Council of the City of Greenville, Bond County, Illinois, as follows:

Section 1. That there be and hereby is approparited for all coporate purposes of the City of Greenville, Illinois, or as much thereof as may be authorized by law, for the fiscal year commencing May 1, 2017 and ending April 30, 2018, the aggregate sum of Thirty-Four Million, Two Hundred Thirty-Five Thousand, Thirty-Six Dollars (\$34,235,036) to be provided for and through the general tax levy of said city for the year 2017 and from other sources of revenue. The objects and purposes for which said aggregate sum is appropriated are as hearinafter set forth.

Section 2. That there be and hereby is appropriated the sum of <u>Two Million</u>, <u>One Hundred Thiry-Five Thousand</u>, <u>Five Hundred Thirty-Six Dollars (\$2,135,536)</u> for Administration and General Government of said city. Unserved Sewer Project Bid and Ownership Recommendation:

City Manager Willey reported that following significant time spent on preliminary work, the unserved sewer project bid opening was held on June 29, 2017. Bids ranged from \$3,529,487.84 to \$4,787,224.00. Low bid was received from Haier Plumbing and Heating. Upon approval of bid, a letter of recommendation is also required to be provided to Rural Development. Motion by Adam, seconded by Gillard, to approve unserved sewer base bid and alternates A and B from Haier Plumbing and Heating for \$3,529,487.84, and to provide a bid recommendation letter from the City of Greenville to Rural Development, subject to Rural Development concurrence, and subject to grant agreement between Rural Development and the City of Greenville.
