#### ORDINANCE NO. 3141

AN ORDINANCE MODIFYING §34.007 OF THE GREENVILLE CODE OF ORDINANCES

OF THE CITY OF GREENVILLE, BOND COUNTY, ILLINOIS

BE IT HEREBY ORDAINED by the Mayor and City Council of the City of Greenville, Bond County, Illinois, as follows:

WHEREAS, §34.007 previously adopted, imposes a residency requirement that Department Heads are required to reside within the City of Greenville; and

WHEREAS, the City Council has determined that it is in the best interest of the health, safety, morals and welfare of the City of Greenville that the residency requirement be modified so that Department Heads are not required to reside within the corporate limits of the City of Greenville, but shall live within five miles of the corporate limits;

NOW THEREFORE, let it be ordained:

SECTION1 - GENERAL STATEMENT: That §34.007 of the Greenville Code of Ordinances is hereby amended as set forth on Exhibit A (attached hereto).

SECTION 2 - EFFECTIVE DATE: This Ordinance shall be in full force and effect from and upon its passage and publication in pamphlet form as provided by law.

SECTION 3 - REPEAL: All prior Ordinances which are inconsistent with the provisions of the Ordinance are hereby repealed.

SECTION 4 – SAVINGS PROVISION: In the event any section, subsection, sentence or phrase of the Ordinance should be declared invalid, all other provision hereof shall not be affected by such invalidity and shall remain in full force and effect.

#### EXHIBIT A

#### 34.007 RESIDENCY REQUIRED FOR DEPARTMENT HEADS

Department heads, while encouraged to reside within the City, must reside within a five mile radius of the City limits. Department heads shall have six months from their date of appointment to meet residency requirements. "Department head" shall mean the Public Works Director, Police Chief, and the City Clerk/Finance Director. Failure to meet residency requirements at any time after the first six months of employment as a department head may result in removal from the position of department head or dismissal.
