AN ORDINANCE AMENDING CHAPTER 150: BUILDING REGULATIONS OF THE CITY CODE OF ORDINANCES, BY THE CITY OF GREENVILLE, BOND COUNTY, ILLINOIS

WHEREAS, it is desired that the Greenville Code of Ordinances Chapter 150: Building Regulations; be amended in the following respects:

That portion of Section 150.02, being:

150.02 BUILDING PERMIT FEES.

(B) No permit is necessary for new shingles, new siding, painting, driveways, sidewalks, new kitchen cabinets and or counters, carpeting or similar finish work.

That portion of Section 150.16, being:

150.16 Definitions

PLUMBING CODE. The Plumbing Code of the city.

are hereby amended and replaced with Section 150.02 which shall say:

150.02 BUILDING PERMIT FEES.

(B) No permit is necessary for new siding, painting, new kitchen cabinets and or counters, carpeting or similar finish work.

and that portion of Section 150.16 which shall say:

150.16 Definitions.

PLUMBING CODE. The current edition of the Illinois State Plumbing Code, as promulgated by the Illinois Department of Public Health or other authorized agency.

NOW, THEREFORE, LET IT BE RESOLVED by the Mayor and the City Council of the City of Greenville, Bond County, Illinois, as follows:

SECTION 1-GENERAL STATEMENT: That effective upon its passage, it is desired that portion Chapter 150: Building Regulations; be amended as outlined above.

SECTION 2-REPEAL: All prior Ordinances and/or Resolutions, which are inconsistent with the provisions of this Ordinance are hereby repealed.

SECTION 3-SAVINGS PROVISIONS: In the event any section, subsection, sentence or phrase of this Ordinance should be declared invalid, all other provisions hereof shall not be affected by such invalidity and shall remain in full force and effect.

SECTION 4-EFFECTIVE DATE: That this Ordinance shall remain in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
