AN ORDINANCE AMENDING CHAPTER 92.02: MONTROSE CEMETERY RULES AND REGULATIONS OF THE CITY CODE OF ORDINANCES, BY THE CITY OF GREENVILLE, BOND COUNTY, ILLINOIS

WHEREAS, it is desired that the Greenville Code of Ordinances Chapter 92.02: Montrose Cemetery rules and regulations; be amended in the following respects:

That portion of Section 92.02, item G, being:

- (G) Any person who shall commit any of the following offenses shall be subject to a fine as set out in this chapter:
 - (1.) Use any loud, obscene or profane language;
 - (2.) Drive any vehicle faster than five mph;
 - (3.) Pick any flowers, break any tree or shrub;
 - (4.) Write upon, break or otherwise deface or damage any stone, market, monument, fence or other structure;
 - (5.) Permit any domestic animal to run at large within said cemetery;
 - (6.) Hunt, discharge fire arms, set off or explode fireworks; or
 - (7.) Otherwise trespass upon any cemetery or burying grounds within the city or any property under its jurisdiction.

is hereby amended and replaced with the new Section 92.02 item G which shall say:

- (G) Any person who does not follow the prescribed regulations shall be subject to a fine as set out in this chapter:
 - (1.) Cemetery hours shall be from dawn to dusk;
 - (2.) Maintain a respectful attitude and volume, and refrain from any loud, obscene or profane language;
 - (3.) Speed limit shall be five mph;
 - (4.) Keep the cemetery clean by using the trash cans provided;
 - (5.) No recreational use of the cemetery (bicycles, roller blades, skates or other recreational modes of transport are prohibited);
 - (6.) No food or drink;
 - (7.) Do not plant any flowers or trees;
 - (8.) Dead or wilted plants may be removed by maintenance;
 - (9.) Do not walk or freshly covered graves;
 - (10.) Do not write upon, break or otherwise deface or damage any stone, market, monument or other structure;
 - (11.) No pets except on a leash. Owners are expected to clean up after their animals;
 - (12.) Hunting is prohibited, discharge of fire arms except for military services is prohibited, and discharge of fireworks is prohibited.

NOW, THEREFORE, LET IT BE RESOLVED by the Mayor and the City Council of the City of Greenville, Bond County, Illinois, as follows:

SECTION 1-GENERAL STATEMENT: That effective November 13, 2018, it is desired that Chapter 92.02: Montrose Cemetery rules and regulations be amended in the following respects:

SECTION 2-REPEAL: All prior Ordinances and/or Resolutions, which are inconsistent with the provisions of this Ordinance are hereby repealed.

SECTION 3-SAVINGS PROVISIONS: In the event any section, subsection, sentence or phrase of this Ordinance should be declared invalid, all other provisions hereof shall not be affected by such invalidity and shall remain in full force and effect.

SECTION 4-EFFECTIVE DATE: That this Ordinance shall remain in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
