ORDINANCE NO. 3193

AN ORDINANCE AMENDING CHAPTER 78, SCHEDULE I OF THE CITY CODE, PROHIBITED PARKING, IN THE CITY OF GREENVILLE, BOND COUNTY ILLINOIS

The City Council of the City of Greenville, Bond County, Illinois, in meeting assembled, does hereby find and determine as follows:

WHEREAS, the City Council for the City of Greenville is authorized pursuant to Chapter 78, Schedule I "Prohibited Parking" of the City of Greenville Code or Ordinances; and

WHEREAS, the City Council has determined that it is in the best interest of the public safety of the residents of the City of Greenville to identify and regulate prohibited parking within the corporate limits.

NOW THEREFORE, let it be ordained by the Mayor and the City Council of the City of Greenville, as follows:

SECTION1 – GENERAL STATEMENT: That Chapter 78, Schedule I, of the Greenville Code is hereby amended to rescind and eliminate the following previously identified as Prohibited Parking:

Intersection of Killarney Drive and Hena Street, terminating 284 feet east of origin, parallel to the curb approximately 271 feet east of the northeast stop sign.

SECTION 2 — EFFECTIVE DATE: This Ordinance shall be in full force and effect from and upon its passage and publication in pamphlet form as provided by law.

SECTION 3 - REPEAL: All prior Ordinances which are inconsistent with the provisions of the Ordinance are hereby repealed.

SECTION 4 - SAVINGS PROVISION: In the event any section, subsection, sentence or phrase of the Ordinance should be declared invalid, all other provision hereof shall not be affected by such invalidity and shall remain in full force and effect.
