AN ORDINANCE AUTHORIZING CANNABIS REFERENDUM QUESTIONS TO BE CERTIFIED TO THE MARCH 17, 2020 ILLINOIS GENERAL PRIMARY ELECTION BALLOT FOR CANNABIS DISPENSARIES AND RELATED ACTIVITIES IN THE CITY OF GREENVILLE, ILLINOIS

WHEREAS, the City of Greenville City Council resolves to place on the March 17, 2020 Illinois General Primary Election Ballot for consideration, the following questions; and

WHEREAS, these advisory referendum questions are authorized by 65 ILCS 5/3.1-40-60: Sec. 3.1-40-60. Advisory referenda. By a vote of the majority of the members of the city council, the council may authorize an advisory question of public policy to be placed on the ballot at the next regularly scheduled election in the municipality. The city council shall certify the question to the proper election authority, which must submit the question at an election in accordance with the Election Code.

- **2. SECTION REPEAL:** All prior ordinances which are inconsistent with the provisions of this ordinance are hereby repealed.
- 3. SECTION SAVINGS PROVISION: In the event any section, subsection, sentence or phrase of this ordinance should be declared invalid, all other provisions hereof shall not be affected by such invalidity and shall remain in full force and effect.
- **4. SECTION EFFECTIVE DATE:** This ordinance shall become in full force and effect from and upon its passage.
