AN ORDINANCE AMENDING CHAPTER 78, SCHEDULE III OF THE MUNICIPAL CODE,
PARKING FOR PERSONS WITH DISABILITIES, IN THE CITY OF GREENVILLE, BOND COUNTY
ILLINOIS

The City Council of the City of Greenville, Bond County, Illinois, in meeting assembled, does hereby find and determine as follows:

WHEREAS, the City Council for the City of Greenville is authorized pursuant to Chapter 78, Schedule III "Parking for Persons with Disabilities" of the City of Greenville Code of Ordinance and also by Illinois Statute to designate parking spaces for persons with disabilities within the corporate limits of the City of Greenville; and

WHEREAS, the City Council has determined that it is in the best interest of the public safety of the residents of the City of Greenville to designate an additional parking space for persons with disabilities at a certain intersection.

NOW THEREFORE, let it be ordained by the Mayor and the City Council of the City of Greenville, as follows:

SECTION1 – GENERAL STATEMENT: That Chapter 78, Schedule III, of the Greenville Code is hereby amended to rescind Ordinance 3231, adopted October 13, 2020, which designated the following:

Designation of a handicap parking space on Second Street between Main Street and College Avenue. Last parking space just before College Avenue, on the east side of Second Street.

Furthermore, Chapter 78, Schedule III, of the Greenville Code is hereby amended to add the following:

Designation of a handicap parking space on Second Street between Main Street and College Avenue. First parking space north of Main Street on the east side of Second Street next to the Second Street Patio.


SECTION 2 – EFFECTIVE DATE: This Ordinance shall be in full force and effect from and upon its passage and publication in pamphlet form as provided by law.

SECTION 3 – REPEAL: All prior Ordinances which are inconsistent with the provisions of the Ordinance are hereby repealed.

SECTION 4 – SAVINGS PROVISION: In the event any section, subsection, sentence or phrase of the Ordinance should be declared invalid, all other provision hereof shall not be affected by such invalidity and shall remain in full force and effect.
