ORDINANCE NO. 3242

AN ORDINANCE AMENDING THE GREENVILLE CODE OF ORDINANCES OF THE CITY OF GREENVILLE, BOND COUNTY, ILLINOIS

BE IT HEREBY ORDAINED by the Mayor and City Council of the City of Greenville, Bond County, Illinois, as follows:

WHEREAS, the Greenville City Council desires to set forth a procedure where the Mayor may designate a signor for written instruments; and

WHEREAS, ILCS 65/3.1-35-30 sets forth the procedure for a Mayor designation for signing instruments;

NOW THEREFORE, let it be ordained:

SECTION1 - GENERAL STATEMENT: The Greenville Code of Ordinances, Chapter 30 City Council be amended to add the following:

The Mayor may, as provided by ILCS 65/3.1-35-30, may designate another to affix his or her signature to any written instrument that requires the Mayor's signature. The Mayor must send written notice of this designation to the City Council stating the name of the person selected and what instrument(s) that person will have the authority to sign. A written signature of the mayor executed by the designated person, with the signature of the designated person underneath, shall be attached to the notice. The notice, with signatures attached, shall be recorded in the minutes and then filed with the municipal clerk.

SECTION 2 - EFFECTIVE DATE: This Ordinance shall be in full force and effect from and upon its passage and publication in pamphlet form as provided by law.

SECTION 3 – REPEAL: All prior Ordinances which are inconsistent with the provisions of the Ordinance are hereby repealed.

SECTION 4 - SAVINGS PROVISION: In the event any section, subsection, sentence or phrase of the Ordinance should be declared invalid, all other provision hereof shall not be affected by such invalidity and shall remain in full force and effect.
