AN ORDINANCE GRANTING GREENVILLE SOLAR, LLC A CONDITIONAL USE PERMIT TO OPERATE A 20-MEGAWATT ELECTRIC POWER GENERATION FACILITY IN GREENVILLE, ILLINOIS

WHEREAS, an application has been filed by Greenville Solar, LLC requesting Conditional Use permit to operate a 20-megawatt electric power generation facility, on unaddressed parcels 05-10-13-319-001, 05-10-13-406-001 and 05-10-13-404-001 along Bowman Avenue, in an Industrial Heavy zone in Greenville, Illinois, and,

WHEREAS, the question of granting said conditional use permit was referred to the Planning Commission of the City of Greenville to hold a public hearing thereon, and,

WHEREAS, said public hearing was duly held on May 26, 2021, after proper public notice in the manner provided by law, and,

WHEREAS, said Commission made a report containing findings of fact and recommending granting of the said amendment.

THERFORE, BE IT ORDAINED by the City Council of the City of Greenville, of Bond County, Illinois, that a conditional use is hereby permitted to Greenville Solar, LLC to operate a 20-megawatt electric power generation facility, on unaddressed parcels 05-10-13-319-001, 05-10-13-406-001 and 05-10-13-404-001 along Bowman Avenue, in an Industrial Heavy zone in Greenville, Illinois, pursuant to the following conditions and or restrictions as set forth by the City Council.

- 1) Final site plan be submitted to City staff for approval prior to building permit.
- 2) Operation and maintenance plan be submitted to City staff for approval prior to building permit.

- 3) Landscape plan for the Bowman Avenue side of the project be developed and submitted to City staff for approval prior to issuance of building permit.
- 4) Landscape plan to include pollinator and native grasses be developed and submitted to City staff for approval prior to issuance of building permit.
- 5) Decommissioning process, including financial surety, be included in the final lease to be approved by the Greenville City Council.

This ordinance shall be effective from and after its passage and approval as required by law.
