AN ORDINANCE AMENDING CHAPTER 95.23: LAKE AND RESERVOIRS, SWIMMING, BATHING AND WADING OF THE CITY CODE OF ORDINANCES, BY THE CITY OF GREENVILLE, BOND COUNTY, ILLINOIS

**WHEREAS**, it is desired that the Greenville Code of Ordinances Chapter 95.23: Swimming, Bathing and Wading; be amended in the following respects:

That portion of Chapter 95, Lakes and Reservoirs, Section 23, Swimming, Bathing and Wading, being:

**95.23 SWIMMING, BATHING AND WADING.**

Swimming, bathing and wading is prohibited in the reservoir, except in areas permitted by the city, except as is necessary in conjunction with the activities permitted in §95.24 of this chapter.

**95.24 WATER SKIING AND SURFBOARD RIDING.**

- A. No water skiing or surfboard riding shall be permitted between the period of sunset and sunrise.
- B. All water skiers or surfboard riders must wear approved life jackets or belts.
- C. All skiers shall hold one ski aloft when they fall in the water.
- D. At least two people must be occupying the boat when pulling a water skier.
- E. No water skiing or surfboard riding is permitted within Zone B or in the areas marked for the boat harbors. All areas for ingress or egress shall be those designated by the city and none other.
- F. Water skiing and surfboard riding is prohibited under all bridges.

is hereby amended and replaced with the new Chapter and Section 95.23, which shall say:

**95.23 SWIMMING, BATHING AND WADING.**

Swimming is permitted only in the reservoir in areas designated by the city, and as is necessary in conjunction with activities permitted in §95.24 of this chapter.

**95.24 WATER SKIING AND SURFBOARD RIDING.**

- A. No water skiing or surfboard riding shall be permitted between the period of sunset and sunrise.
- B. All water skiers or surfboard riders must wear approved life jackets or belts.
- C. All skiers shall hold one ski aloft when they fall in the water.
- D. At least two people must be occupying the boat when pulling a water skier.

- E. No water skiing or surfboard riding is permitted within Zone B or in the areas marked for the boat harbors. All areas for ingress or egress shall be those designated by the city and none other.
- F. Water skiing and surfboard riding is prohibited under all bridges.

NOW, THEREFORE, LET IT BE RESOLVED by the Mayor and the City Council of the City of Greenville, Bond County, Illinois, as follows:

**SECTION 2-REPEAL:** All prior Ordinances and/or Resolutions, which are inconsistent with the provisions of this Ordinance are hereby repealed.

**SECTION 3-SAVINGS PROVISIONS:** In the event any section, subsection, sentence or phrase of this Ordinance should be declared invalid, all other provisions hereof shall not be affected by such invalidity and shall remain in full force and effect.

**SECTION 4-EFFECTIVE DATE:** That this Ordinance shall remain in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
