ORDINANCE VACATING AN ALLEY

WHEREAS, a request was received by Greenville University to vacate an alley in Greenville, Illinois, which is described as follows;

The alley running from North to South between First Street and N. Prairie Street between College Avenue and Oak Street.

WHEREAS, the request is made to allow for new dormitory facilities;

WHEREAS, the Plan Commission has held a Public Hearing on March 28, 2022 and has recommended approval of the request to vacate the alley running from North to South between First Street and N. Prairie Street between College Avenue and Oak Street;

WHEREAS, the City Council reviewed the request and recommends vacating the alley running from North to South between First Street and N. Prairie Street between College Avenue and Oak Street.

BE IT ORDAINED by the City Council of the City of Greenville, of Bond County, Illinois, that the alley running from North to South between First Street and N. Prairie Street between College Avenue and Oak Street is hereby vacated and to be split 50/50 to the adjoining property owners per state statute.

This ordinance shall be effective from and after its passage and approval as required by law.
