ORDINANCE NO. 3267  
ORDINANCE VACATING A STREET

WHEREAS, a request by Greenville University to vacate a street in, Greenville, Illinois, which is described as follows;

Portion of First Street running from North to South between E. College Avenue and E. Oak Street.

WHEREAS, the request is made to allow for new dormitory facilities;

WHEREAS, the Plan Commission has held a Public Hearing on March 28, 2022 and has recommended approval of the request to vacate a portion of First Street running from North to South between E. College Avenue and E. Oak Street.

WHEREAS, the City Council reviewed the request and recommends vacating the portion of First Street running from North to South between E. College Avenue and E. Oak Street.

BE IT ORDAINED by the City Council of the City of Greenville, of Bond County, Illinois, that a Portion of First Street running from North to South between E. College Avenue and E. Oak Street is hereby vacated and to be split 50/50 to the adjoining property owners per state statute.

This ordinance shall be effective from and after its passage and approval as required by law.
