## AN ORDINANCE TO AMEND CITY CODE AN ORDINANCE TO AMEND CITY CODE 95.23 SWIMMING IN THE RESERVOIR FOR THE CITY OF GREENVILLE

The City Council of the City of Greenville, Bond County, Illinois, in meeting assembled, does hereby find and determine as follows:

**WHEREAS**, the City Council for the City of Greenville is desirous to amend swimming in the reservoir as defined in the City Code; and,

WHEREAS, it is in the best interest of the health, safety and welfare of the citizens of the City of Greenville to adopt an ordinance to amend the city code, namely §95.23 which currently reads, "Swimming is permitted only in the reservoir in areas designated by the city, and as is necessary in conjunction with activities permitted in § 95.24 of this chapter." Change to read, "Swimming is permitted in all areas of the reservoir in no wake zones unless as designated as 'no swimming' by the City, and as is necessary in conjunction with activities permitted in § 95.24 of this chapter."

**NOW THEREFORE**, let it be ordained by the Mayor and the City Council of the City of Greenville as follows:

**SECTION 1 – GENERAL STATEMENT:** The City of Greenville's City Council hereby amends city code §95.23 to read: "Swimming is permitted in all areas of the reservoir in no wake zones unless as designated as 'no swimming' by the City, and as is necessary in conjunction with activities permitted in § 95.24 of this chapter."

**SECTION 2 – REPEAL:** All prior Ordinances which are inconsistent with the provisions of this Ordinance are also hereby repealed.

**SECTION 3 – SAVINGS PROVISIONS:** In the event any section, subsection, sentence or phrase of this Ordinance should be declared invalid, all other provisions hereof shall not be affected by such such invalidity and shall remain in full force and effect.

**SECTION 4 – EFFECTIVE DATE:** This Ordinance shall become in effective and in full force from and upon its passage.
