**ORDINANCE NO. 3297**

**AN ORDINANCE AMENDING SECTION 153.0202 (A) OF  
THE CITY OF GREENVILLE CODE OF ORDINANCES**

**WHEREAS**, the Greenville city council is authorized in Sec. 153.0660 et seq to adopt certain amendments to the code, and further required protocols for such an amendment have been followed.

**WHEREAS**, the city desires to amend said code to create a conditional use for a maintenance shed/facility located within a commercial neighborhood zone.

**WHEREAS**, it is the best interest of the health, safety, morals, and welfare for this amendment be entered.

**NOW, THEREFORE, LET IT BE ORDAINED** by the Mayor and the City Council of the City of Greenville as follows:

**SECTION 1-GENERAL STATEMENT:** Sec. 153.0202 (A) is hereby amended to incorporate a recognized conditional use for a “maintenance shed/facility”.

**SECTION 2-REPEAL:** All prior Ordinances which are inconsistent with the provisions of this Ordinance are also hereby repealed.

**SECTION 3-SAVINGS PROVISIONS:** In the event any section, subsection, sentence or phrase of this Ordinance should be declared invalid, all other provisions hereof shall not be affected by such invalidity and shall remain in full force and effect.

**SECTION 4-EFFECTIVE DATE:** This Ordinance shall become in full force and effect from and upon its passage.


