ORDINANCE NO. 3298

**A ORDINANCE GRANTING A CONDITIONAL USE
PERMIT TO KINGSBURY PARK DISTRICT TO
ACCOMMODATE A MAINTENANCE SHED/FACILITY**

WHEREAS, pursuant to Sec. 153.0202 (A) of the City of Greenville code (as amended) the City is authorized to grant a conditional use permit for a storage shed/ facility.

WHEREAS, the Kingsbury Park District has heretofore made application for a conditional use to accommodate a maintenance shed/facility in a commercial neighborhood.

WHEREAS, all substantive and procedural requirements have been met, and it is in the best interests of the City of Greenville to grant this conditional use permit pursuant to Sec. 153.0700 et seq.

NOW, THEREFORE, LET IT BE ORDAINED by the Mayor and the City Council of the City of Greenville as follows:

SECTION 1-GENERAL STATEMENT: The Kingsbury Park District is hereby granted a conditional use permit to accommodate a maintenance shed/ facility in a commercial neighborhood zone pursuant to Sec. 153.0202 (A) and Sec. 153.0700 et seq.

SECTION 2-REPEAL: All prior Ordinances which are inconsistent with the provisions of this Ordinance are also hereby repealed.


SECTION 3-SAVINGS PROVISIONS: In the event any section, subsection, sentence or phrase of this Ordinance should be declared invalid, all other provisions hereof shall not be affected by such invalidity and shall remain in full force and effect.


SECTION 4-EFFECTIVE DATE: This Ordinance shall become in full force and effect


