**AN ORDINANCE AMENDING SECTION 73.41 THE  
CITY OF GREENVILLE CODE OF ORDINANCES BY  
GIVING BOND COUNTY EXCLUSIVE JURISDICTION  
OVER PERMITTING OF GOLF CART AND OFF  
HIGHWAY VEHICLES**

WHEREAS, the Greenville city council is authorized in Sec. 153.0660 et seq to adopt certain amendments to the zoning code, and further required protocols for such an amendment have been followed.

WHEREAS, the city desires to amend said code re permitting of golf cart and off road vehicles.

WHEREAS, it is the best interest of the health, safety, morals, and welfare for this amendment be entered.

NOW, THEREFORE, LET IT BE ORDAINED by the Mayor and the City Council of the City of Greenville as follows:

**SECTION 1-GENERAL STATEMENT:** Sec. 73.41 is hereby amended to give exclusive permitting jurisdiction to Bond County (see attached Exhibit A).

**SECTION 2-REPEAL:** All prior Ordinances which are inconsistent with the provisions of this Ordinance are also hereby repealed.

**SECTION 3-SAVINGS PROVISIONS:** In the event any section, subsection, sentence or phrase of this Ordinance should be declared invalid, all other provisions hereof shall not be affected by such invalidity and shall remain in full force and effect.

**SECTION 4-EFFECTIVE DATE:** This Ordinance shall become in full force and effect from and upon its passage.



## Exhibit A

### **"73.41 SLOW MOVING VEHICLE REQUIREMENTS.**

All persons wishing to operate an allowed non-highway vehicle on the city streets must ensure compliance with the following requirements:

- (A) Proof of current mandatory liability insurance as required by Article VI of the Illinois Vehicle Code.
- (B) Must have the vehicle certified by the County by inspection by the Sheriff or designated representative.
- (C) Must display County decal on rear of the vehicle, which will be applied upon successful completion of vehicle inspection."
