# VILLAGE OF HANNA CITY PEORIA COUNTY, ILLINOIS ORDINANCE NUMBER 13-10-01

AMENDMENT OF TITLE 17, CHAPTER 171, SECTION 171.01(E)
AN ORDINANCE REGULATING WATER AND SEWER SERVICE RATES
WITHIN THE VILLAGE OF HANNA CITY, ILLINOIS, SPECIFICALLY, AMENDING THE
COMBINED WATER AND SEWER RATE FOR RESIDENTIAL CUSTOMERS.

WHEREAS, Illinois American Water Company has increased the cost of the Village's source water; and

WHEREAS the Village Board deems it necessary and in the best interests of the Village to make amendments to the Village Code to recoup all or part of this increase;

NOW, THEREFORE, IT IS HEREBY ORDAINED by the President and Board of Trustees of the Village of Hanna City, Peoria County, Illinois, as follows:

- 1. The foregoing recitals are hereby incorporated herein as if fully set forth.
- 2. The following provisions of Title 17, Chapter 171, Section 171.01(E) of the Hanna City Village Code shall be amended in regard to water charge dollar amounts to read as follows:

#### MONTHLY WATER SERVICE CHARGES

The minimum charge for water and sewer combined services shall be \$39.44 per month.

The minimum charge for water and sewer combined services for nonresidential users located outside the corporate limits of the Village shall be \$71.58 per month.

All other provisions of Chapter 171, Public Works Regulations, not in conflict with these provisions hall remain in full force and effect.

- 3. This Amendment shall become effective immediately.
- 4. Should any provision of this ordinance be held invalid by a court of law or administrative tribunal, such other portions as are not found to be invalid shall remain in full force and effect.
