 ORDINANCE NUMBER 20-12-01

AMENDMENT TO TITLE V, PUBLIC WORKS, CHAPTER 51, SECTION 51.05
 AN ORDINANCE REGULATING WATER AND SEWER SERVICE RATES
 WITHIN THE VILLAGE OF HANNA CITY, ILLINOIS, SPECIFICALLY, AMENDING THE
 MINIMUM WATER AND COMBINED WATER AND SEWER RATE FOR RESIDENTIAL
 AND NONRESIDENTIAL CUSTOMERS

WHEREAS, Illinois American Water Company has increased the cost of the Village's source water by approximately 24.3% over the past eight years; and

WHEREAS, pursuant to 65 ILCS 5/11-126-4, the corporate authorities of the Village of Hanna City are authorized to fix and collect from the Village's inhabitants the rates for the use and benefit of water supplied to them; and

WHEREAS the corporate authorities of the Village of Hanna City deem it necessary and in the best interests of the Village to make amendments to the Village Code to recoup all or part of this increase in the cost of the Village's source water;

NOW, THEREFORE, IT IS HEREBY ORDAINED by the President and Board of Trustees of the Village of Hanna City, Peoria County, Illinois, as follows:

1. The foregoing recitals are hereby incorporated herein as if fully set forth.
2. The following provisions of Title V, Public Works, Chapter 51, Section 51.05 of the Hanna City Village Code shall be amended in regard to water charge dollar amounts to read as follows:

The fixed rates or charges for the use of, and for the service supplied by, the combined waterworks and sewerage system of the Village, based upon the amount of water consumed as shown by the water meters, are as follows:

<i>Monthly Water Service Charges</i>	
First 4,000 gallons	\$9.97 per 1,000 gallons water consumed
Next 5,000 gallons	\$6.19 per 1,000 gallons water consumed
Next 5,000 gallons	\$5.86 per 1,000 gallons water consumed
Next 5,000 gallons	\$4.90 per 1,000 gallons water consumed
Over 19,000 gallons	\$3.21 per 1,000 gallons water consumed
Minimum water fee	\$23.94 per month based upon the first 2,400 gallons used
Minimum sewer fee	\$20 per month for the first 2,400 gallons of water used
	An additional charge of \$0.35 per each 100 gallons of water used up to 10,000 gallons
	\$0.12 per 100 gallons of water used over 10,000 gallons
Minimum charge for water and sewer	\$43.94 per month

combined services	
Multiple units	If more than one living unit and/or using unit are served by a single metered connection to the system, then the owner of the multi-unit property shall be responsible to pay the bills for each un-metered living unit and/or using unit as reflected by the said meter and shall pay a sewer charge of \$20 and a single meter convenience fee of \$5 per unit regardless of occupancy in addition to the usual monthly service charges for water use per the single meter. If a building or structure has multiple living units, each with its own water meter, but no Village-owned curb stops exist outside of the building for the purpose of shutting water off to each individual unit, then the owner of the building, not the individual resident of each unit, will be responsible for the water deposit and the monthly bills and will receive the monthly bills for each unit until such time when curb stops are installed.
Fire hydrant rental	An annual minimum charge of \$1,650 or at the rate of \$82.50 per hydrant, whichever is greater. The charges are to be made against the village and paid to the Water and Sewer Fund in equal monthly installments.
Lawn and fire sprinkler system service	Residential and commercial customers requiring a separate water service line and/or meter for fire protection and/or lawn sprinkler system use shall be charged a minimum sum of \$6 per month per extra line and/or meter plus the regular rates, minus the sewer fee applicable.
<i>Nonresidential Users</i>	
Nonresidential users located outside the corporate limits of the Village shall be charged for water use according to the following schedule:	
First 4,000 gallons	\$19.43 per 1,000 gallons water consumed
Next 5,000 gallons	\$12.87 per 1,000 gallons water consumed
Next 5,000 gallons	\$11.55 per 1,000 gallons water consumed
Next 5,000 gallons	\$9.72 per 1,000 gallons water consumed
Over 19,000 gallons	\$6.43 per 1,000 gallons water consumed
Minimum charge for water service	\$46.63 based upon the first 2,400 gallons consumed
Minimum charge for water and sewer combined services	\$80.63

Unless modified by a vote of the corporate authorities of the Village of Hanna City, the minimum charge for water service shall increase by 2.7% on January 1 each year, beginning on January 1, 2022.

All other provisions of Title V, Public Works, not in conflict with these provisions shall remain in full force and effect.


3. This Amendment shall become effective immediately.

4. Should any provision of this ordinance be held invalid by a court of law or administrative tribunal, such other portions as are not found to be invalid shall remain in full force and effect.

5. The Village Clerk shall file a certified copy of this ordinance with the Peoria County Clerk.


