AN ORDINANCE FIXING COMPENSATION FOR CERTAIN MEMBERS OF THE
CORPORATE AUTHORITIES OF THE VILLAGE OF HANNA CITY

WHEREAS, the Village of Hanna City has the authority to adopt ordinances and to promulgate rules and regulations that protect the public health, safety and welfare of its citizens; and

WHEREAS, pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*, the Village of Hanna City may increase the salaries or other compensation of any appointed municipal officer so as to take effect during the term for which the officer was appointed; and

WHEREAS, the Village Clerk is an appointed office in the Village of Hanna City; and

WHEREAS, the members of the combined Planning Commission/Zoning Board of Appeals are appointed officers in the Village of Hanna City; and

WHEREAS, the Village Clerk currently participates in, and helps facilitate, meetings of the combined Planning Commission/Zoning Board of Appeals without compensation; and

WHEREAS, the members of the combined Planning Commission/Zoning Board of Appeals currently serve the Village of Hanna City on a voluntary basis without compensation; and

WHEREAS, the combined Planning Commission/Zoning Board of Appeals plays an integral role in Village governance and the Village desires to provide compensation to its members and the Village Clerk for their service and dedication to such Commission/Board; and

WHEREAS, the Village Board of the Village of Hanna City has deemed it advisable and in the best interest of the Village to compensate the Village Clerk and the members of the combined Planning Commission/Zoning Board of Appeals for their participation in the meetings of such Commission/Board; and

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Hanna City, Peoria County, Illinois, as follows:

Section 1. The foregoing recitals are hereby incorporated herein as if fully set forth.

Section 2. The Village Clerk and the members of the combined Planning Commission/Zoning Board of Appeals shall be compensated as set forth below:

The Village Clerk shall be compensated at a rate of \$75.00 per regular Meeting of the President and Board of Trustees attended, for up to twenty-four (24) regular Meetings attended per Fiscal Year. The Village Clerk shall be further

compensated at a rate of \$75.00 per combined Planning Commission/Zoning Board of Appeals Meeting attended, for up to twelve (12) combined Planning Commission/Zoning Board of Appeals Meetings attended per Fiscal Year.

Each of the six (6) members of the combined Planning Commission/Zoning Board of Appeals shall be compensated at a rate of \$25.00 per combined Planning Commission/Zoning Board of Appeals Meeting attended, for up to twelve (12) combined Planning Commission/Zoning Board of Appeals Meetings attended per Fiscal Year.


Section 3. The compensation set forth herein shall be budgeted for and reflected in the Village of Hanna City's 2021-2022 Annual Appropriations Ordinance.

Section 4. Should any portion of this Ordinance be held invalid or illegal, the remaining portions hereof shall continue in full force and effect.

Section 5. This Ordinance shall be in full force and effect following its passage, publication and approval as required by law.
