ORDINANCE NO. 2021-06-04

## AN ORDINANCE PROHIBITING THE OPERATION OF UTVs (UTILITY TASK VEHICLES) ON VILLAGE STREETS

WHEREAS, the Village of Hanna City has the authority to adopt ordinances and to promulgate rules and regulations that protect the public health, safety and welfare of its citizens; and

WHEREAS, pursuant to the Illinois Vehicle Code, 625 ILCS 5/1-100 et seq., the Village of Hanna City may restrict the types of non-highway vehicles that are authorized to be used on Village streets and may prohibit the operation of low-speed vehicles on Village streets; and

WHEREAS, the Village Board of the Village of Hanna City has deemed it necessary and in the best interest of the Village to amend certain provisions of the Village Code relating to the operation of non-highway and low-speed vehicles on Village streets; and

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Hanna City, Peoria County, Illinois, as follows:

Section 1. The foregoing recitals are hereby incorporated herein as if fully set forth.

**Section 2.** Chapter 71 of the Village Code of the Village of Hanna City shall be amended as follows:

Section 71.02 shall be amended to add to the definition of "non-highway vehicle" a subpart (c) which shall read as follows:

(c) recreational off-highway vehicles, including UTVs ("utility task vehicles"), as defined by Section 1-168.8 of the Illinois Vehicle Code.

Section 71.06 shall be amended in its entirety and shall read as follows:

## § 71.06 OPERATION OF NON-HIGHWAY VEHICLES ON VILLAGE STREETS

Non-highway vehicles, including ATVs, UTVs, and off-highway motorcycles, but excluding golf carts, shall not be operated on Village streets and alleys at any time. Any and all violations of this Section shall be subject to penalties as set forth in Section 71.99 of this Chapter.

**Section 3.** Should any portion of this Ordinance be held invalid or illegal, the remaining portions hereof shall continue in full force and effect.

**Section 4.** This Ordinance shall be in full force and effect from and after ten (10) days following its passage, publication and approval as required by law.
