AN ORDINANCE AMENDING THE VILLAGE OF HANNA CITY LIQUOR LICENSING
ORDINANCE AND ESTABLISHING ANNUAL FEES FOR LIQUOR LICENSE
CLASSIFICATIONS

WHEREAS, the Village of Hanna City has the authority to adopt ordinances and to promulgate rules and regulations that protect the public health, safety and welfare of its citizens; and

WHEREAS, pursuant to the Liquor Control Act of 1934, 235 ILCS 5/1-1 *et seq.*, the President and Board of Trustees of the Village of Hanna City have the power to determine, by ordinance or resolution, the number, kind and classification of licenses for sale at retail of alcoholic liquor and the amount of the local license fees to be paid for the various kinds of licenses; and

WHEREAS, the Village of Hanna City has in place Village Code Section 111.10 establishing the classifications and fees related to local liquor licenses and supplemental licenses within the Village of Hanna City; and

WHEREAS, the President and the Board of Trustees of the Village of Hanna City have determined that it is in the best interest of the Village of Hanna City to amend the liquor licensing code for the purpose of identifying the fee amounts for each classification of liquor license available for issuance in the Village of Hanna City; and

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF HANNA CITY, PEORIA COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. The foregoing recitals are hereby incorporated herein as though fully set forth.

Section 2. The second sentence of subsection (A) of Section 111.10 of the Village Code is hereby amended in its entirety and shall read as follows:

The annual fee for a Class A license shall be \$500.00 per license year.

Section 3. The second sentence of subsection (B) of Section 111.10 of the Village Code is hereby amended in its entirety and shall read as follows:

The annual fee for a Class B license shall be \$500.00 per license year.

Section 4. The second sentence of subsection (C) of Section 111.10 of the Village Code is hereby amended in its entirety and shall read as follows:

The annual fee for a Class E license shall be \$500.00 per license year.

Section 5. The second sentence of subsection (D) of Section 111.10 of the Village Code is hereby amended in its entirety and shall read as follows:

The fee for each Sub-Class One license issued shall be \$250.00 per license year.

Section 6. The second sentence of subsection (E) of Section 111.10 of the Village Code is hereby amended in its entirety and shall read as follows:

The Sub-Class Two license shall issue automatically upon the payment of \$25.00 per video gaming terminal authorized by the Video Gaming Act and the furnishing to the Village a copy of the Video Gaming Act license issued by the state for the Village-licensed premises for the time period covered by the primary Village liquor license. Such Sub-Class Two license fee per video gaming terminal shall be required per license year.

Section 7. Should any portion of this Ordinance be held invalid or illegal, the remaining portions hereof shall continue in full force and effect.

Section 8. This Ordinance shall be in full force and effect immediately following its passage, publication and approval as required by law.
