ORDINANCE NO. 21-07-07

AN ORDINANCE IMPOSING A MUNICIPAL TELECOMMUNICATIONS TAX IN THE VILLAGE OF HANNA CITY

WHEREAS, the Village of Hanna City has the authority to adopt ordinances and to promulgate rules and regulations that protect the public health, safety and welfare of its citizens; and

WHEREAS, pursuant to the Simplified Municipal Telecommunications Tax Act, 35 ILCS 636/5-1 *et seq.*, the Village of Hanna City is authorized to impose by ordinance a tax upon the act or privilege of originating or receiving in the Village intrastate or interstate telecommunications by a person; and

WHEREAS, the Village of Hanna City is not currently receiving distributions for telecommunications taxes on gross charges for telecommunications purchased at retail within the Village; and

WHEREAS, the Village of Hanna City has deemed it necessary and in the best interest of the Village to impose a Simplified Municipal Telecommunications Tax pursuant to the Simplified Municipal Telecommunications Tax Act, 35 ILCS 636/5-1 et seq.; and

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Hanna City, Peoria County, Illinois, as follows:

- **Section 1.** The foregoing recitals are hereby incorporated herein as if fully set forth.
- **Section 2. Tax Imposed.** A simplified municipal telecommunications tax is hereby imposed upon the act or privilege of originating in the Village of Hanna City or receiving in the Village of Hanna City intrastate or interstate telecommunications by a person at the rate of five percent (5%) of the gross charges for such telecommunications purchased at retail from a retailer, in accordance with and subject to the provisions of the Simplified Municipal Telecommunications Tax Act, 35 ILCS 636/5-1 *et seq*.
- Section 3. Clerk to File Ordinance with Illinois Department of Revenue. The Village Clerk is hereby directed to file a certified copy of this Ordinance with the Illinois Department of Revenue prior to September 20, 2021.
- **Section 4. Effective Date.** This Ordinance shall be in full force and effect from and after its passage, approval, and publication as required by law, provided, however, that Section 2 of this Ordinance shall take effect for all gross charged billed by telecommunications retailers on (i) the first day of July next following the adoption and filing of this Ordinance with the Department of Revenue, if filed on or before the preceding March 20th, or (ii) the

first day of January next following the adoption and filing of this Ordinance with the Department of Revenue, if filed on or before the preceding September 20th.

Section 5. Repeal of Conflicting Provisions. All ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of the conflict, hereby repealed on the effective date of Section 2 of this Ordinance.

Section 6. Severability. Should any portion of this Ordinance be held invalid or illegal, the remaining portions hereof shall continue in full force and effect.
