ORDINANCE NO. 22- 04 - 02

AN ORDINANCE APPROVING A CONTRACT FOR RESIDENTIAL WASTE  
COLLECTION AND DISPOSAL SERVICES BETWEEN THE VILLAGE OF HANNA CITY  
AND GFL ENVIRONMENTAL, INC. AND ESTABLISHING RATES FOR SUCH  
SERVICES

WHEREAS, the Village of Hanna City has the authority to adopt ordinances and to promulgate rules and regulations that protect the public health, safety and welfare of its citizens; and

WHEREAS, pursuant to Section 11-19-1 of the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*, the Village of Hanna City may make contracts with any person, for more than one year and not to exceed 30 years, relating to the collection and final disposition of garbage, refuse and ashes; and

WHEREAS, pursuant to Section 11-19-5 of the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*, the corporate authorities of the Village of Hanna City may provide such method or methods for the disposition of garbage, refuse and ashes, and may provide by ordinance that such method or methods shall be the exclusive method or methods for the disposition of garbage, refuse and ashes to be allowed within the Village, notwithstanding the fact that competition may be displaced by such ordinance; and

WHEREAS, pursuant to Section 11-19-4 of the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*, the corporate authorities of the Village of Hanna City may, by ordinance, assess a service charge to finance the establishment and maintenance of systems or plants, by contract or by direct provision, for the collection, disposal, treatment or recycling of garbage, refuse and ashes; and

WHEREAS, the Village of Hanna City has sought and received proposals for the collection and disposal of waste within the Village; and

WHEREAS, the proposal received by GFL Environmental, Inc. for the collection and disposal of garbage and refuse, for a period of five years, contains additional services beneficial to the Village's residents, including home landscape waste pick-up services and one bulk service home pick-up; and

WHEREAS, the Village of Hanna City has not increased its rates for waste collection services since 2014; and

WHEREAS, pursuant to Section 92.12(C) of the Village of Hanna City Code of Ordinances, the minimum monthly fee for the collection of garbage and waste materials shall be set by the Board of Trustees from time to time; and

WHEREAS, the President and Board of Trustees have determined that the proposal submitted by GFL Environmental, Inc. will most beneficially meet the Village's needs for waste collection and disposal services; and

WHEREAS, the President and Board of Trustees have determined that an increase in the service charges for waste collection and disposal services is necessary to defray the costs associated with contracting for such services; and

WHEREAS, the President and Board of Trustees of the Village of Hanna City find and hereby declare that it is in the best interests of the Village and its residents to approve the Contract attached hereto and made a part hereof, and to increase the service charges for the services to be rendered pursuant to such Contract;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Hanna City, Peoria County, Illinois, as follows:

**Section 1.** The foregoing recitals are hereby incorporated as if fully set forth herein.

**Section 2.** The President and Board of Trustees of the Village of Hanna City hereby approve the Contract between the Village of Hanna City and GFL Environmental, Inc., attached hereto and made a part hereof, and the President and Village Clerk shall be and are hereby authorized and directed to execute said Contract in substantially the form attached hereto.

**Section 3.** The monthly service charge for waste collection and disposal services in the Village of Hanna City shall be \$14.50 per month, with such rate to take effect September 1, 2022.

**Section 4.** Should any portion of this Ordinance be held invalid or illegal, the remaining portions hereof shall continue in full force and effect.

**Section 5.** This Ordinance shall be in full force and effect following its passage, approval, and publication in pamphlet form as required by law.
