“AN ORDINANCE LEVYING THE TAXES FOR THE CURRENT FISCAL YEAR
ENDING APRIL 30, 2026”

A resolution providing for and the making of the tax levy for the twelve months beginning May 1, 2025 and ending April 30, 2026 for the uses and purposes herinafter set forth for the Village of Hecker in the State of Illinois after adoption of an appropriation ordinance number 25- 11 adopted on December 9, 2025.

Whereas, the Village Trustees of the Village of Hecker, Illinois has determined that it is necessary to raise the sum of \$48,599 for the purposes set forth below:

NOW, THEREFORE, BE IT ORDAINED by the Village Trustees of the Village of Hecker, Illinois:

Section 1: That there be and is hereby levied upon all the taxable property within the corporate limites of said Village of Hecker, Illinois, as the same in assessed and equalized for State and County taxation for the fiscal year ending April 30, 2026, the sum of FORTY-eight THOUSAND FIVE HUNDRED NINETY-NINE DOLLARS AND NO CENTS (\$48,599) for the following specific purposes mentioned in said Appropriation Ordinance and in the respective sums as follows:


