**A RESOLUTION APPROVING AN OPERATING AGREEMENT FOR THE  
MAINTENANCE AND OPERATION OF THE VILLAGE'S POTABLE WATER  
FACILITY AND WATER INFRASTRUCTURE AND THE WASTEWATER  
COLLECTION AND TREATMENT FACILITIES**

WHEREAS, the Village of Hecker ("Village"), St. Clair and Monroe Counties, Illinois is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, the Village is responsible for maintenance and operation of the potable Water Facility and Water Infrastructure and the Wastewater Collection and Treatment Facilities which serves the Village of Hecker; and

WHEREAS, Hydro Services, Inc. is qualified to and agrees to fulfill all requirements set forth under applicable laws and regulations for the operation of such facility and certain segments of the infrastructure; and

WHEREAS, the Village and Hydro Services, Inc. have agreed to enter into an Operating Agreement, a copy of which is attached as Exhibit "A" and incorporated herein by reference, that sets forth the duties and responsibilities of the respective parties.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and the Board of Trustees of the Village of Hecker, as follows:

- Section 1.* The foregoing recitals are incorporated herein as findings of the Board of Trustees of the Village of Hecker, Illinois.
- Section 2.* The proposed Operating Agreement between the Village of Hecker and Hydro Services, Inc. is approved.
- Section 3.* The Village President is hereby authorized and directed to execute said Agreement.
- Section 4.* This Resolution shall be effective upon its passage and approval in accordance with law.
