

**A RESOLUTION AUTHORIZING THE APPROVAL OF A JOINT AGREEMENT

BE IT RESOLVED by the President and Village Board of Trustees of the Village of Hecker, Monroe County, Illinois, as follows:

The Board of Trustees of the Village of Hecker do hereby authorize the village to enter into a joint agreement with Monroe County for the drainage improvements to North Park Steet with an estimated cost of \$150,000 to be split 50/50 with both parties.

JOINT AGREEMENT
VILLAGE OF HECKER AND THE COUNTY OF MONROE FOR
NORTH PARK STREET DRAINAGE IMPROVEMENTS

Whereas, The Village of Hecker (Village) and the County of Monroe (County) in the interest of improved transportation facilities and to obtain proper drainage desire to install gutters and storm sewer along North Park Street, and


Whereas, The Provision of 605 ILCS 5/5-501, provides that the County and qualifying Municipalities may jointly construct drainage structures along any public road within said municipality, and

Whereas, The Village meets the assessed evaluation and population requirements of the statutes and by signatures hereon does petition the County of Monroe for assistance, under provisions of 605 ILCS 5/5-501.


Now, Therefore, be it agreed that by their seals below the two parties, jointly enter into a contract for said improvement under the aforesaid provisions and conditions as follows:

- A) Work will be in accordance with plans and estimated cost prepared by the County with a total estimated cost of \$150,000 being split 50/50 between the Parties of this Agreement. Estimate attached.
- B) The Village shall reimburse the County for 50% of the actual project cost upon completion of the work, with any work exceeding 110% of the project line item estimate requiring pre-approval by the Village.
- C) Work will be completed by a qualified contractor paying the prevailing wage approved by both the Village and the County.
- D) Construction supervision shall be by the County.
- E) The Village shall obtain any necessary easements and notify the Public and Property Owners of the details and schedule of the project and coordinate any road/driveway closures.
