RESOLUTION NO. R03-2024

A RESOLUTION APPROVING A DRAINAGE WATERWAY AGREEMENT

WHEREAS, the Village of Hecker (“Village”), St. Clair and Monroe Counties, Illinois is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, the Village has a need for waterway drainage on the west side of Eldondale Subdivision; and

WHEREAS, Dale Haudrich has agreed to give the Village a 20 foot drainage waterway easement that extends across his parcel #12-05-200-001-000; and

WHEREAS, the Village and Mr. Haudrich have agreed to enter into a Drainage Waterway Agreement, a copy of which is attached as Exhibit “A” and incorporated herein by reference, that sets forth the duties and responsibilities of the respective parties; and

WHEREAS, the Corporate Authorities desire to enter into this Agreement for the creation and maintenance of the drainage waterway.


NOW, THEREFORE, BE IT RESOLVED, by the Mayor and the Board of Trustees of the Village of Hecker, as follows:

- Section 1.* The foregoing recitals are incorporated herein as findings of the Board of Trustees of the Village of Hecker, Illinois.
- Section 2.* The proposed Drainage Waterway Agreement between the Village of Hecker and Dale Haudrich, as well as the attached Permanent Drainage Waterway easement are approved.
- Section 3.* The Village President is hereby authorized and directed to execute said Agreement.
- Section 4.* This Resolution shall be effective upon its passage and approval in accordance with law.
