**ORDINANCE NO. 25-04**

**AN ORDINANCE OF THE BOARD OF TRUSTEES OF THE VILLAGE OF MARISSA,  
ILLINOIS, AMENDING SECTION 1-2-2 OF THE VILLAGE CODE**

**WHEREAS**, the Village of Marissa, St. Clair County, Illinois (“Village”), is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

**WHEREAS**, a public meeting was held in the Village of Marissa, Illinois at the Marissa Village Hall, 111 N. Main Street, Marissa, Illinois, on June 2, 2025, at 7:00 p.m., before the Village Board of Marissa and notice of said meeting was duly given; and

**WHEREAS**, the Marissa Village Code currently provides regulations for the holding of regular board meetings; and

**WHEREAS**, the Village desires to amend Section 1-2-2 of its Village Code as follows (deletion in strikethrough and addition in italics):

**§1-2-2 REGULAR MEETINGS**. The regular stated meetings of the Village Board shall be held in the Village Hall Building on the first (1<sup>st</sup>) Monday and third (3<sup>rd</sup>) ~~Wednesday~~ *Monday* of each month at 7:00 P.M. When the meeting date falls upon a legal holiday, the meeting shall be held on the following day at the same hour and place, unless otherwise designated. Adjourned and reconvened meetings may be held at such times as may be determined by the Trustees. (See 65 ILCS Sec. 5/3.1-40-25 and 5 ILCS Sec. 120/1 et seq.)

**WHEREAS**, the President and Board of Trustees of the Village have determined that it is in the best interest of the Village to make the aforementioned amendment to the Village Code.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MARISSA, ST. CLAIR COUNTY, ILLINOIS, AS FOLLOWS:**

**Section 1:** That the foregoing recitals are hereby incorporated herein as findings of the President and Board of Trustees.

**Section 2:** That Section 1-2-2 of the Village Code shall be amended to read as follows:

**§1-2-2 REGULAR MEETINGS**. The regular stated meetings of the Village Board shall be held in the Village Hall Building on the first (1<sup>st</sup>) Monday and third (3<sup>rd</sup>) Monday of each month at 7:00 P.M. When the meeting date falls upon a legal holiday, the meeting shall be held on the following day at the same hour and place, unless otherwise designated. Adjourned and reconvened meetings may be held at such times as may be determined by the Trustees. (See 65 ILCS Sec. 5/3.1-40-25 and 5 ILCS Sec. 120/1 et seq.)

**Section 3:** All other sections of Section 1-2-2 shall remain in full force and effect.

**Section 4:** The amendment herein shall first be effective upon those meeting dates occurring after July 1, 2025.

**Section 5:** All other Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

**Section 6:** This Ordinance shall be in full force and effect from and after its passage and approval, and as further stated herein, and after publication in pamphlet form, as provided by law.
