

ORDINANCE 2026- 01

TAX LEVY ORDINANCE

WHEREAS, the Village of Marissa (“Village”), St. Clair County, Illinois is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, a public meeting was held in the Village of Marissa, Illinois at the Marissa Village Hall, 111 N. Main Street, Marissa, Illinois, on January 5, 2026, at 7:00 p.m., before the Village Board of Marissa and notice of said meeting was duly given; and

WHEREAS, the Board of Trustees of the Village of Marissa, in the County of St. Clair and State of Illinois, have asked that an Ordinance for the Levy and Assessment of Taxes for the current Fiscal Year be adopted, the amount of which is ascertained to be the aggregate sum of FIFTY-FOUR THOUSAND AND ONE HUNDRED AND FORTY-EIGHT DOLLARS (\$54,148.00).

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF THE TRUSTEES OF THE VILLAGE OF MARISSA, ST. CLAIR COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. The foregoing recitals shall be and are hereby incorporated as findings of fact as if said recitals were fully set forth herein.

SECTION 2. That there be and is hereby levied all taxable property within the corporate limits of said Village of Marissa, subject to taxation for the year A.D., 2025, the total of TWENTY-EIGHT THOUSAND, THREE HUNDRED AND FIFTY-ONE DOLLARS (\$28,351.00), for the General Fund of said Village only, for the following specific purposes mentioned, and in the respective as follows, to wit:

SECTION 3.

1. That the amount appropriated and levied for operation of the Police Department be a .075% and that amount levied be SEVEN THOUSAND, SEVEN HUNDRED AND SIX DOLLARS (\$7,706.00).
2. That the amount appropriated and levied for Garbage Disposal be a .12% and the amount levied be NINE THOUSAND AND SIX DOLLARS (\$9,006.00).

3. That the amount appropriated and levied for liability insurance be NINE THOUSAND AND EIGHTY-FIVE DOLLARS (\$9,085.00).

SECTION 4. The Clerk of said Village is hereby directed to file with the County Clerk of said County a duly certified copy of this Ordinance.

SECTION 5. This Ordinance shall take effect and be in force from and after its passage and shall replace Tax Levy Ordinance #2025-01 passed, and approved January 9, 2025.


