AN ORDINANCE AMENDING CHAPTER 82. TRAFFIC AND VEHICLES. ARTICLE III. PARKING, STANDING AND STOPPING. DIVISION 3. RESTRICTED AREAS. SEC. 82-116. FIFTEEN-MINUTE PARKING ZONES DESIGNATED.

BE IT ORDAINED by the City Council of the City of Marshall, Illinois:

Section 1. That Chapter 82. Traffic and Vehicles. Article III. Parking, Standing and Stopping. Division 3. Restricted Areas. Sec. 82-116. Fifteen-minute parking zones designated of the Code of Ordinances, City of Marshall, Illinois is hereby amended to read as follows, with strikeouts indicating deletions in text and underscores indicating additions to text:

Sec. 82-116. Fifteen-minute parking zones designated.

No vehicle shall be parked in the following streets within the boundaries indicated for longer than 15 minutes:

Archer Avenue, on the north side of Archer Avenue directly in front of the Marshall Public Library known as 614-616 Archer Avenue.

North Seventh Street, in front of the United States Post Office as marked by the painted curb.

Plum Street, south to the alley on both east and west sides of North Seventh Street as marked by the painted curb.

Section 2. If any provision of this Ordinance, or application thereof, is held invalid by any Court, other provisions or applications of this Ordinance which can be given effect without

the invalid provision or application shall not be affected, and to this end the provisions of this Ordinance are declared to be severable.

Section 3. That this Ordinance shall take effect ten (10) days after its passage and approval as provided by law.
