AN ORDINANCE AMENDING CHAPTER 2. ADMINISTRATION. ARTICLE VI.
FINANCE. SEC. 2-307. PURCHASING REQUIREMENTS.

BE IT ORDAINED by the City Council of the City of Marshall,
Illinois:

Section 1. That Chapter 2. Administration. Article VI.
Finance. Sec. 2-307. Purchasing Requirements of the Code of
Ordinances, City of Marshall, Illinois is hereby amended to read
as follows, with strikeouts indicating deletions in text and
underscores indicating additions to text:

Sec. 2-307. Purchasing requirements.

All employees who are authorized to make purchases for the city
shall obtain a written quote and shall get the approval of the
mayor, or in the absence of the mayor the approval of the chairman
of the applicable council committee, before purchasing any supply
or equipment for ~~\$3,000.00~~ 5,000.00 or more at any one time.

Section 2. If any provision of this Ordinance, or
application thereof, is held invalid by any Court, other provisions
or applications of this Ordinance which can be given effect without
the invalid provision or application shall not be affected, and to
this end the provisions of this Ordinance are declared to be
severable.

Section 3. That this Ordinance shall take effect ten (10)
days after its passage and approval as provided by law.
