AN ORDINANCE AMENDING CHAPTER 82. TRAFFIC AND VEHICLES. ARTICLE III. PARKING, STANDING AND STOPPING. DIVISION 4. STOP STREETS. SEC. 82-129. FOUR-WAY INTERSECTIONS DESIGNATED OF THE CODE OF ORDINANCES, CITY OF MARSHALL, ILLINOIS.

Section 1. That Chapter 82. Traffic and Vehicles. Article III. Parking, Standing and Stopping. Division 4. Stop Streets. Sec. 82-129. Four-Way Intersections Designated of the Code of Ordinances, City of Marshall, Illinois is hereby amended to read as follows, with strikeouts indicating deletions in text and underscores indicating additions to text:

Sec. 82-129. Four-way intersections designated.

The following intersections are hereby designated as four-way stop intersections:

Route 1 and Archer Avenue.

Fifth Street and Locust Street.

Sixth Street and Archer Avenue.

Sixth Street and Locust Street.

Sixth Street and Plum Street.

Eight Street and Mulberry Street.

Tenth Street and Beech Street.

Tenth Street and Plum Street

Tenth Street and Lincoln Drive.

11th Street and Maple Street.

11th Street and Vine Street.

Chestnut Street and South Michigan Avenue.

Walnut Street and South Michigan Avenue.

Section 2. If any provision of this Ordinance, or application thereof, is held invalid by any Court, other provisions or applications of this Ordinance which can be given effect without the invalid provision or application shall not be affected, and to this end the provisions of this

Ordinance are declared to be severable.

Section 3. That this Ordinance shall take effect ten (10) days after its passage and approval as provided by law.
