## AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE TOWN OF MILLS RIVER, NORTH CAROLINA AND OFFICIAL MAP

WHEREAS, the Town Council for the Town of Mills River enacted the Zoning Ordinance for the Town of Mills River, effective March 1, 2004, including the official Zoning Map for the Town of Mills River;

WHEREAS, the owner(s) of all certain real property have applied pursuant to Chapter 154, Subchapter 154.195 of the Zoning Ordinance to amend the Zoning Ordinance and the official Zoning Map to rezone the their real property from Mills River MR-NC Neighborhood Commercial to Mills River MR-LI Light Industrial; and

## NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MILLS RIVER:

THAT, the Zoning Ordinance for the Town of Mills River, North Carolina and the official Zoning Map of the Town of Mills River hereby shall be and are amended to rezone the property identified as PIN 9631615703, 9631724062, 9631629737, and 9631736291 of the Henderson County Registry from Mills River MR-NC Neighborhood Commercial to MR-LI Light Industrial. The official Zoning Map of the Town of Mills River as amended herein shall be available in the office of the Town of Mills River from and after the effective date of this Ordinance.

This ordinance and the amendment to the Zoning Ordinance for the Town of Mills River, North Carolina and the official Zoning Map of the Town of Mills River shall take effect and be in full force and effect on the and after the date of adoption.
