

An ORDINANCE to RESCIND the 45 MPH ZONE  
on NC HIGHWAY 280/191  
in MILLS RIVER, NORTH CAROLINA

WHEREAS, the North Carolina Department of Transportation (NCDOT) asks the Mills River Town Council for concurrence on rescinding the 45 MPH speed zone on North Carolina Highway 280/Highway 191;

WHEREAS, the NCDOT asks the Mills River Town Council to rescind the following Municipal Speed Limit:


<u>Speed Limit</u>	<u>Route</u>	<u>Description</u>
45	NC 280- NC 191	Between a point 0.06 miles east of SR 1332 (Presbyterian Church Road) and a point 0.10 miles east of SR 1338 (South Mills River Road).


WHEREAS, the Mills River Town Council met Wednesday, April 5, 2017 and voted unanimously to concur with the Department of Transportation on rescinding the 45 MPH speed zone on North Carolina Highway 280/Highway 191:

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN OF MILLS RIVER TOWN COUNCIL:

THAT, the above-referenced Municipal Speed Limit shall be rescinded when the NCDOT has passed a concurring ordinance and signs are erected giving notice of the authorized speed limit.
