ORDINANCE 20A-2022

AN ORDINANCE APPROVING NAVARRE-STARK COUNTY
SANITARY SEWAGE SERVICE AGREEMENT

Whereas, the Village of Navarre is preparing to undertake a reconstruction and expansion of its wastewater treatment plant ("the Project"), and

Whereas, Stark County has historically used a majority of the plant's capacity to treat wastewater, carried in County owned lines to the plant, and

Whereas, Stark County is willing to share the cost of the Project, but desires that such be memorialized in a written agreement, and

Whereas, a written agreement has been negotiated and prepared, and


Whereas, on October 3, 2022, Council approved a version of the written agreement, and

Whereas, since October 3, 2022, the written agreement has been modified,

Now, therefore, be it ordained by the Council of the Village of Navarre, Ohio, that

(1) That the Mayor is authorized to enter into and sign the Navarre-Stark County Sanitary Sewage Service Agreement, as proposed and negotiated as of this date, subject to approval of the Village Solicitor, and

(2) This ordinance shall take effect at the earliest time permitted by law. This ordinance is deemed an EMERGENCY, not requiring three readings, the Emergency being that time is of the essence to finalize and enter into a funding agreement with the County, at an early enough time that the Village can pursue a design contract, design of the Project and submission of same to Ohio Environmental Protection Agency for a permit to install, and thereafter to bid the Project and construct it, and further as the Project will permit expedited industrial or commercial development, and should therefore be passed as an EMERGENCY, with the number of votes necessary to waive the three readings rule and adopt this measure as an EMERGENCY.
