EMERGENCY ORDINANCE ACCEPTING THE ALTERNATE FORMULA FOR DISTRIBTUION OF LOCAL GOVERNMENT AND LOCAL GOVERNMENT REVENUE ASSISTANCE FUNDS AS PROPOSED BY THE STARK COUNTY COUNCIL OF GOVERNMENTS AND AS PRESCRIBED BY OHIO REVISED CODE, SEC. 5747.33

Whereas, the Village of Navarre has been requested to consider and approve the alternate formula for distribution of local government revenue assistance funds as proposed by the Stark County Council of Governments, and

Whereas, said proposal is reasonable and for the benefit of the residents of the Village of Navarre,

Now Therefore, Village Council, having considered the above at a regularly scheduled public meeting, Resolves to Adopt the following estimated formula proposed by the Stark County Council of Governments, for a five year period, commencing with the calendar year 2023 and ending with the calendar year 2027, to distribute local government and local government revenue assistance funds, said estimated formula contained on the attachment labeled "Appendix A."

The Mayor is authorized and directed to execute, on behalf of the Village of Navarre, the Alternative Method Agreement as proposed by the Stark County Council of Governments to carry out the proposed 2023-2027 distribution of local government revenue assistance funds.

The Village Clerk-Treasurer is directed to certify a copy of this resolution to the Stark County Auditor.

This Ordinance is declared to be an Emergency, being necessary for immediate preservation of public peace, health or safety of residents of and visitors to the Village of Navarre, and being further necessary to comply with fiscal deadlines leading to implementation of Stark County Council of Governments funding for 2023. This Ordinance shall then take effect immediately upon passage and signature by the Mayor.
