VILLAGE OF NAVARRE STARK COUNTY, OHIO ORDINANCE NO. 3-2024

AN ORDINANCE ENACTING NEW SECTION 30.08 TO VILLAGE MUNICIPAL REGULATIONS, PERMITTING PURCHASE OF VEHICLES WITHOUT PUBLIC BID, FROM OTHER OHIO POLITICAL SUBDIVISIONS AND FROM PUBLIC JOINT PURCHASING PROGRAMS

Whereas, Ohio Revised Code, Sec. 735.053 permits Ohio political subdivisions to purchase or sell vehicles, without public bid, to/from other Ohio political subdivisions, provided such purchases are authorized by legislative resolution, and

Whereas, Ohio Revised Code, Sec. 9.48(c) permits Ohio political subdivisions to purchase vehicles, without public bid, through public joint purchasing programs,

Now Therefore, Village Council Ordains and enacts new Section 30.08 of the Village Codified Municipal Regulations, which shall read as follows –

"Section 30.08 - Purchase and Sale of Vehicles without Public Bid

- (A) The Village, through its Mayor or Administrator, is authorized to purchase vehicles from, or sell vehicles to, other Ohio political subdivisions, without public bid, provided that each such purchase or sale is approved by Village Council by written resolution.
- (B) The Village, through its Mayor or Administrator, is authorized to purchase vehicles, without public bid, under any public joint purchasing program that meets the requirements of Ohio Revised Code, Sec. 9.48(c), provided that each such purchase is approved by Village Council by written resolution."
