ORDINANCE 4-2022 AUTHORIZING THE CLERK-TREASURER OF THE VILLAGE OF NAVARRE, OHIO TO TRANSFER FUNDS WITHIN THE VARIOUS AUTHORIZED CATEGORIES OF ALLOCATIONS ENUMERED HEREIN, AND DELCARING SAME TO BE AN EMERGENCY

WHEREAS, it is in the best interest of the health, safety and welfare of the residents of the Village of Navarre that the Clerk-Treasurer of said Village be authorized to transfer funds within the several enumerated categories, as described here; and

WHEREAS, said transfers are necessary due to prior and pending budgetary allocations; NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NAVARRE, STATE OF OHIO, THAT:





Therefore, this ordinance shall take effect immediately upon its passage by Council, and signature of the Mayor, in compliance with and as provided for by the Ohio Revised Code, sections 731.17 and 731.30.


