ORDINANCE NO. 6-2024

AN ORDINANCE AWARING CONTRACT FOR FOHL ST. S. W. TURN
LANE PROJECT TO UNITED EARTHWORKS, LLC

Whereas the Village of Navarre, Ohio publicly advertised for sealed bids for a certain construction project, "Fohl St. S. W. Turn Lane" (the Project), in accordance with applicable provisions of the Ohio Revised Code, and

Whereas, on April 22, 2024, sealed bids were opened, and the low bidder was United Earthworks, LLC, in the lump sum of \$780,000, and

Whereas, the Engineer has determined that, under all of the circumstances, the United Earthworks bid is a qualified bid from a qualified bidder, and

Whereas, United Earthworks has completed two other recent and similar projects within the Village of Navarre in a satisfactory fashion and

Whereas, time is of the essence, as the Project needs to be completed before the onset of inclement weather, which weather could impact the long-term quality of work on the Project,

Now Therefore, The Village Council of Navarre, Ohio Ordains and Authorizes the Village Administrator to enter into a contract with United Earthworks, LLC, in a form acceptable to the Village Solicitor, in the amount of \$780,000.

Wherefore, this ordinance will take effect and be in full force immediately upon its adoption by council and approval by the Mayor. Further, Council declares this Ordinance to be an emergency, being reasonably necessary for the fiscal well-being of the Village, and for the safety of persons living in or traveling through the Village using the Fohl-Sterilite intersection safely to be reconstructed with the addition of a traffic signal, and so that the Project may be concluded before arrival of inclement weather, to be passed with the requisite number of votes necessary to waive the three reading rule and be passed as an emergency.


