ORDINANCE NO. 8-2022

AN ORDINANCE REPLATTING THREE EXISTING LOTS  
(PARCELS) TO CREATE ONE NEW LOT (PARCEL) AND  
AUTHORIZING SUBMISSION OF SAME  
TO COUNTY AUDITOR AND RECORDER

Whereas, Kenneth C. and Mickie L. Diehl are the owners of three parcels within the Village of Navarre, being Lots 7, 8, and part of 9, also being Stark County tax parcels 1200285, 1200256, and 1200314, and

Whereas, a re-plat mylar has been created by a registered surveyor, whereby the three parcels would be re-platted into a single combined parcel, which shall be Navarre Lot 917, to which the Stark County Auditor may assign a new permanent tax parcel number, and

Whereas, re-plat were prepared in mylar form by registered surveyor Jerry L. Nichols and signed by him on February 15, 2022, and

Whereas, the Village Engineer, Donald R. Dummermuth, has reviewed said re-plat mylar and approved same, and

Whereas, the owners, Kenneth C. and Mickie L. Diehl, have reviewed said re-plat mylar, and approved same, and

*Now Therefore, the Village Council of Navarre, Ohio Ordains as follows:*

(1) That Lots 7, 8, and part of 9 (Stark County tax parcels 1200285, 1200256, and 1200314) be re-platted and renumbered as Lot 917 (a 0.781 acre parcel), and

(2) That the re-plat mylar shall be submitted to the Stark County Auditor, together with a certified copy of this ordinance, and thereafter to the Stark County Recorder, for recording of the re-plat mylar and this ordinance.
