	AN ORDINANCE GRANTING FALCON BASEBALL AND SOFTBALL PRIORITY FOR USE OF VILLAGE OF NAVARRE CONTROLLED BASEBALL AND SOFTBALL FIELDS FOR 2022
	Whereas, historically, the Village has granted Falcon Youth Baseball and Softball priority for use of Village controlled baseball and softball fields, and
	Whereas, Falcon Youth Baseball and Softball has requested such priority be granted for the calendar year 2022, and
	Whereas, Bethlehem Township's Board of Trustees has approved such priority for baseball and softball fields at the shared Navarre-Bethlehem Community Park, and
	Whereas, the Village deems Falcon Youth Baseball and Softball to be responsible users who encourage baseball and softball among younger people,
	Now Therefore, the Village Council of Navarre, Ohio Ordains as follows:
	(1) That on the baseball and softball fields controlled by the Village, Falcon Youth Baseball and Softball is granted first priority to schedule and utilize such fields in 2022, with others being able to use such fields when not being used by Falcon Youth Baseball and Softball, and
:	(2) That on the baseball and softball fields jointly controlled by the Village and Bethlehem Township, Falcon Youth Baseball and Softball is granted first priority to schedule and utilize such fields in 2022, provided that Falcon Youth Baseball and Softball maintains such right of priority with Bethlehem Township, with others being able to use such fields when not being used by Falcon Youth baseball and Softball, and
	(3) That Falcon Youth Baseball and Softball maintain liability insurance covering the use of such fields, naming the Village or the Village/Bethlehem Township as additional insureds, and provide the Village with proof of such insurance, and
	(4) Wherefore, this Ordinance shall take effect and be in full force immediately upon its adoption by Council and approved by the Mayor. Further, Council declares that this ordinance, being reasonably necessary for the health, welfare, and safety of the Village of Navarre, particularly as it establishes field use priority in time for the start of baseball and softball season, which season is fast approaching, and inasmuch as the subject of this Ordinance was discussed by Council in an open meeting on March 7, 2022, and should therefore be passed as an EMERGENCY, with the number of votes necessary to waive the three readings rule and adopt this measure as an EMERGENCY.
