RESOLUTION AUTHORIZING VILLAGE ADMINISTRATOR AND MAYOR
TO ENTER INTO GAS AGGREGATION CONTACT WITH NEW SUPPLIER

Whereas, the Village of Navarre currently participates in a gas aggregation program for the benefit of its residents, and the supplier currently is Volunteer Energy, which has recently filed for bankruptcy protection, and

Whereas, the bankruptcy filing has raised concerns over continued access to natural gas from Volunteer Energy and the rates applicable to such, after the end of the current contract period, and

Whereas, the Village of Navarre engaged Buckeye Energy Brokers to shop for a replacement supplier with a favorable rate structure and reliability of service, and

Buckeye Energy Brokers has identified a reliable and competitively priced replacement supplier, IGS Energy, that could replace Volunteer Energy at the end of the current contract period, and

The Village of Navarre has an interest in seeing that its residents receive uninterrupted natural gas service,

Now Therefore, Village Council Resolves as follows –

That the Village of Navarre, through its Mayor and/or Village Administrator may enter into a natural gas aggregation agreement with IGS Energy, on such terms as they deem favorable, on behalf of the residents of the Village of Navarre.

This Resolution is deemed an emergency by Council, as time is of the essence to prevent interruption of natural gas service to the Village's residents, and to procure a favorable natural gas price structure in a period of extremely volatile energy pricing.
