RESOLUTION NO. 2023-16

RESOLUTION AUTHORIZING CONTRIBUTION OF JOINT
ECONOMIC DEVELOPMENT DISTRICT FUNDS TO NEW
TRAFFIC SIGNAL AND TURN LANE AT STERILITE/FOHL INTERSECTION

Whereas, the Village of Navarre currently has on deposit the sum of \$58,111.62 funds in its Joint Economic Development District fund, and

Whereas, the Village of Navarre currently has access to \$454,196.70 matching funds from Ohio Department of Development (formerly Ohio Development Services Agency) for work on Sterilite Street to the intersection with Fohl Road, said funds needing to be matched by other funds to be available, and said funds needing to be expended on or before December 31, 2024 or be forever lost, and

Whereas, it appears that, for traffic safety reasons, it is advisable to add a traffic signal and turn lane at the Sterilite Street / Fohl Road intersection, and a preliminary estimate of the cost of such is in excess of \$900,000, and


Whereas, the Village of Navarre is seeking contributions from other sources, in an effort to capture the \$454,196.70 available funds, and

Whereas, the Sterilite Street / Fohl Road intersection lies within the boundaries of the Joint Economic Development District, and is directly related to business development of undeveloped parcels within the industrial park as well as to traffic safety in the area,

Now Therefore, Village Council Resolves as follows –

That the Village of Navarre authorize contribution of \$50,000 from the Joint Economic Development District fund to the project to add a traffic signal and turn lane to the Sterilite Street / Fohl Road intersection, and that three readings should be waived as time is of the essence to procure funds commitments from other sources, complete design of the improvements for review by Ohio Departments of Development and Transportation, competitively bid the project and complete it before publicly available funds expire.


