RESOLUTION NO. 2023-18

RESOLUTION RATIFYING ACTION BY VILLAGE
COUNCIL AUTHORIZING EXPENDITURE OF UP
TO \$150,000 FOR PARK CAPITAL GRANT EXPENSES

Whereas, Bethlehem Township, acting on behalf of the Navarre-Bethlehem Community Park and on behalf of both Bethlehem Township and the Village of Navarre, has received a grant commitment for certain community park improvements of up to \$150,000, and

Whereas, the political subdivisions have identified up to \$150,000 of improvements that are eligible for reimbursement under the grant, and said improvements are found to be necessary to maintain and improve the Navarre-Bethlehem Community Park, said improvements to include stream erosion control, park road paving and striping, handicap parking sign/post, park entrance signs, with metal sign artwork, park structure roof and gutters/downspouts, playground equipment, and bridge work, and

Whereas, the Village's partner, Bethlehem Township has approved expenditure of up to \$150,000 for said improvements from said grant funds, and


Whereas, on May 15, 2023, Village Council, after having received a full report on the proposed improvements, found same to necessary and reasonable and also approved expenditure of up to \$150,000 for said improvements from said grant funds, such approval to be reflected in the minutes of the meeting of May 15, 2023,

Now Therefore, Navarre Village Council Resolves as follows –

That Navarre Village Council expressly ratifies its action of May 15, 2023, so that the Village Administrator and Fiscal Officer are authorized to take all action necessary to construct the aforesaid improvements for the Navarre-Bethlehem Community Park, from said grant funds and in partnership with Bethlehem Township, and

That, time is of the essence in approving this appropriation, and this Resolution is passed with the number of votes required to avoid any three reading requirement.


