RESOLUTION NO. 2023-19

RESOLUTION RATIFYING PRIOR ACTION OF VILLAGE
COUNCIL AUTHORIZING PURCHASE OF POLICE CRUISER

Whereas, the Navarre police department had previously, with Village Council approval, ordered a new police cruiser, with estimated delivery in about two years, and

Whereas, the Navarre police department has now identified a potential replacement cruiser described as a Ford AWD Utility Interceptor that is immediately available, from Statewide Ford Lincoln, of Van Wert, Ohio, at a cost of \$45,659 net, and

Whereas, the Village of Navarre may cancel the previously ordered police cruiser for no cost, particularly inasmuch as there was no guarantee that the previously ordered police cruiser could be delivered and had not yet been fully priced, and

Whereas, Village Council on May 15, 2023 authorized cancellation of the previously ordered police cruiser and purchase of the replacement cruiser for the sum of up to \$45,659 from Statewide Ford Lincoln, said approval to be reflected in the minutes of the meeting of May 15, 2023, and

Whereas, the Village has funds on hand to pay for the replacement cruiser,

Now Therefore, Village Council Resolves as follows --

That the Village of Navarre, through its Village Fiscal Officer, may cancel the first police cruiser order, and purchase the replacement cruiser from Statewide Ford Lincoln, for the sum of up to \$45,659, and that three readings should be waived as the new police cruiser is vital to the health and safety of the residents of and of visitors to the Village of Navarre, and with delayed delivery times for most police cruisers, quick action is needed to secure this one.




